## III. Old Business

- a. Adoption of Rules
- i. Younger teams need 3 REFs, no exceptions (must be certified)
- 1. Lines people should not be affliated with the team, unless agreed by both teams-can only direct balls in or out PERIOD. See Section 4.06 of Abronzino rules.
- ii. It is recommended that you bring a copy of the rules to the game and the Smart Book.
- iii. Changes proposed to blended rules
- 1. Motion to adopt playing rules that have been posted with caveat that small changes may be made with notice. Motion made by Paul Sallaberry. Motion passed unanimously.
- iv. REF is not responsible for knowing League specific rules.
- v. Teams should be on oppose sides of half way line, 10 years away.
- vi. REF assault or abuse will go directly to the District. Can occur before, during or after match.
- 1. Refer to CA Youth Soccer Asso. Discipline and Appeals manual, for definition of assault and abuse.
- b. Player transferring from Class I to Class III is acceptable, however will not be eligible to play in Association Cup. Any exceptions must be approved by Dave Mann.

## IV. New Business

- a. Ref issue from SC United presented by Scott Johnson. Action will be followed with District.
- b. Red card disciplinary actions questioned by Juventus.
- i. Are there guidelines?
- ii. District II has database of players tracking yellow and red cards. League maintains knowledge specific to team issues.
- iii. Appeals can be made to League Board. District tournaments are appealed to the District. Appeal should be written and sent to srstern@home.com with check for \$50.00. Returned only if appeal is passed.
- 1. When red card is received a call and email is sent to coach/manager. Once game card is in, another call and email is sent with judgement. If there is an appeal, it must be done within 2 days of notification of judgement.
- 2. Once player has served penalty and Ref signatures for serving penalty have been received, pass is sent to Disciplinary Chair who brings it to the following League board meeting.
- 3. If you send a self-addressed envelop, it will help out tremendously.
